



**CHULA VISTA COMMUNITY COLLABORATIVE
PARTNERS MEETING MINUTES
October 11, 2016**

1. Margarita Holguin welcomed everyone and introductions were made.
2. **Annual CVCC Highlights**, Margarita Holguin. The CVCC Annual Highlights was handed out and Margarita provided a quick review.
3. **McAlister Institute (New Hope Teen Recovery Center) NHTRC**, Laura Martinez. The Center is located on 24th Street and open to youth ages 12-17 yrs who are parenting or pregnant. Program's mental health and alcohol/tobacco/other drugs services are offered in English & Spanish. Laura discussed the many services, including co-op childcare; court approved parenting classes, and infant message classes. She also discussed the referral process, fees and graduation. 4. **Job Corp**, Marcella Campo and Alejandra Aceves. A brief history of Job Corp education and training program was provided. Information covered the youth residential program, the academics & job skills trainings programs. Job Corp supports other agencies by offering manpower at the worksites. They have also developed partnerships which allow hands-on training. Qualifications for youth 16-24 include: age waiver for disability, low income, US Citizen or legal resident with work permit or social security number; must show interest in certificate, not disruptive or on court probation, no fines over \$500 and have reliable transportation. 5. **American Diabetes Association**, Diana Velo. A PowerPt was presented. Information on the focus on the Latino community, mission and resources were provided. The differences between Type 1 & 2 diabetes were discussed. Several events are upcoming, including a walk on Oct. 22nd Step Out Walk to Stop Diabetes; National Healthy Lunch Day Nov. 15th; Tour de Cure April 29th; and Alert Day on May 4th.
